A physician and researcher who proved the world's largest anthrax epidemic was due to biological warfare. She revealed the dangers of the anthrax vaccine, investigated Gulf War Syndrome, and challenged the FBI's investigation of the anthrax letters. She has given 6 Congressional testimonies and many testimonies to state legislatures on bioterrorism, vaccine safety, COVID and public health. She has consulted the World Bank, the Cuban Ministry of Health and the Director of National Intelligence. She is a scientific advisor for Children's Health Defence.
